Your comment must remain visible until winners are confirmed. Your account must allow direct messages (DMs) so we can contact you if you win.

Entries must be made by natural persons using their own accounts. Entries on behalf of others are not permitted.

Three (3) winners will each receive one (1) license for the WALLS VST plugin by Klevgrand (the "Prize").
