#### The Task

# The Competition Period

The ADAM Audio Soundtrack Competition 2025 competition (hereinafter "Competition") starts on October 17, 2025, and ends on November 15, 2025.

- → Round 1 (Submission Phase): October 17, 2025 November 2, 2025, 11:00 p.m. CFT
- → Round 2 (Public Voting): November 10, 2025 November 15, 2025. The winners will be announced on November 16, 2025, on the ADAM Audio competition landing page and via email notification.

#### How to Enter the Competition

To participate, entrants must:

- 1. Compose an original soundtrack for the official ADAM Audio A7V video clip (available for download in horizontal or vertical format).
- 2. Upload the finished soundtrack with or without the video to their own account on Instagram, Facebook, TikTok, SoundCloud, or YouTube.
- 3. Include the hashtag #soundtrackcompetition 2025 in the title of their post.
- 4. Complete and submit the official participation form available on the ADAM Audio website, including all mandatory fields.
- 5. Please set your account to "public" for the duration of the competition.

Only entries for which all required information is provided in the participation form and which comply with these conditions will be considered valid. Each participant may only submit one (1) entry. Multiple entries or entries made through automated means will not be accepted.



# The Prizes

#### 1st Prize:

- → 1 pair of ADAM Audio A7V studio monitors
- $\rightarrow$  A fee of 1,000 EUR (gross)
- → Credit in the finalized A7V video clip and/or video description

#### 2nd Prize:

Among all voters in Round 2, one (1) ADAM Audio H200 headphone will be raffled.

Prizes are non-transferable and cannot be exchanged for cash. ADAM Audio reserves the right to replace any prize with an equivalent item if necessary.

# Winner Selection and Notification

ADAM Audio's internal team will select the five (5) finalists from all valid entries.

The final winners will then be determined through a public vote conducted between November 10 and November 15, 2025 on the competition landing page:

Finalists and winners will be notified via the email address provided in the participation form. If a winner does not respond within three (3) months after notification (16.02.2026), the Organizer reserves the right to select another winner.

# Content Requirements and Rights of Use

Participants must ensure that:

- → The submitted soundtrack is their own original work.
- → No rights of third parties (including copyright, neighboring rights, trademark, or personal rights) are infringed.
- → Any samples, loops, or sound libraries used are properly licensed for commercial use.



#### Al-Generated Content:

The submission of soundtracks that are wholly or partly generated or modified using artificial intelligence (AI) systems is prohibited. All entries must be the original, human-created work of the participant. ADAM Audio reserves the right to exclude or disqualify entries that violate this provision.

By entering the Competition, participants grant ADAM Audio a non-exclusive, worldwide, royalty-free right to use the submitted soundtrack for the purposes of conducting and promoting the Competition, including:

- → Reproduction, public performance, and communication to the public in connection with the Competition and its results (e.g., on ADAM Audio's website, social media, or press materials).
- → Public presentation in the final A7V promotional video (in the case of the winning entry).

For the winning entry, the participant grants ADAM Audio an additional exclusive, unlimited right of use for all media (including online, broadcast, and event use), as part of the commissioned A7V video clip. In return, the winner will receive the stated prize (Section "The Prizes — 1st Prize") as full remuneration.

Participants retain ownership of their copyrights in all cases.

#### Exclusion from participation

Participation in the ADAM Audio Soundtrack Competition 2025 is open to any natural person aged 18 or older. Participation is open worldwide, unless prohibited by local law in the participant's country of residence. Employees of ADAM Audio GmbH, affiliated companies, or cooperation partners involved in the Competition, as well as their relatives, are excluded from participation.

Participation is free of charge and not dependent on the purchase of any product.

# <u>Liability</u>

ADAM Audio assumes no liability for technical failures, delays, or data losses related to participation.

Participants are responsible for ensuring that their entries comply with all applicable laws and third-party rights.

Any legal claim by third parties arising from an infringement caused by a participant shall be borne solely by that participant. Nothing in these terms shall exclude or limit



liability for damages resulting from injury to life, body, or health, or for damages caused intentionally or by gross negligence. Any further liability shall be excluded.

# **Exclusion and Disqualification**

ADAM Audio reserves the right to exclude participants from the Competition in cases of:

- → Violation of these Conditions of Participation,
- → Manipulation or attempted manipulation of the Competition,
- ightarrow Providing false or misleading information, or
- → Offensive, discriminatory, or unlawful content.

#### Changes, Suspension, or Termination

ADAM Audio may modify, suspend, or terminate the giveaway if necessary for reasons beyond its reasonable control (e.g., fraud, technical issues, legal or regulatory requirements). Any material changes will be reasonably communicated.

# 2. Purpose and Legal Basis of Processing

Personal data provided via the participation form (name, email address, country, and URL of the soundtrack) will be processed exclusively for the following purposes:

- → Announcement of finalists and winners.

The legal basis for processing is Art. 6(1)(b) GDPR (performance of a contract or precontractual measures) and, where applicable, Art. 6(1)(a) GDPR (consent).

If you agree to receive the ADAM Audio newsletter, your email address will additionally be processed based on Art. 6(1)(a) GDPR. You can revoke this consent at any time with effect for the future.



# 3. Recipients of Data

Personal data will be processed internally by ADAM Audio employees responsible for organizing the Competition and, if necessary, by service providers (e.g., IT or marketing partners) strictly bound by data processing agreements (Art. 28 GDPR).

Data will not be transferred to third countries outside the EU without an adequate level of protection. Data will not be subject to automated decision-making or profiling within the meaning of Article 22 GDPR.

# 4. Storage Period

All Competition-related personal data will be deleted after completion of the Competition (no later than March 31, 2026), unless statutory retention obligations or consent for further use (e.g. newsletter subscription) apply.

# 5. Rights of Data Subjects

Participants have the following rights under the GDPR:

- Right of access (Art. 15 GDPR),
- Right to rectification (Art. 16 GDPR),
- Right to erasure (Art. 17 GDPR),
- Right to restriction of processing (Art. 18 GDPR),
- Right to data portability (Art. 20 GDPR), and
- Right to object (Art. 21 GDPR).
